### ***COMPANIES CROSSING BORDERS***

#### **Organisation:**

Organised by the Faculty of Law of the University of Antwerp, Belgium  
Other Law Faculties involved in the organizing and/or teaching of the course:  
Radboud University of Nijmegen (The Netherlands) and Universidad Autónoma de Madrid (Spain).

#### **Subject:**

The summer course pursues content appropriate to deepen the study of some aspects of interest in the field of European Union law and involves areas of study that are relevant to train European jurists. More in particular, the summer course focuses on key legal considerations for companies crossing borders. This is done from various perspectives: mergers & acquisitions, (aggressive) tax (planning), employment, intellectual property, insolvency, international contracts, social dumping and human rights. Relevant EU legislation and case law in each of these domains are scrutinized. The cross-border aspects of these various perspectives are at the centre of attention. In addition to seminars, the summer course also includes a case relating to companies involved in a cross-border take-over situation, to be solved by the students in groups throughout the summer school. The students' solutions are discussed interactively and extensively in tutorials from the aforementioned various perspectives. An intensive learning experience with maximum impact is guaranteed thanks to the international composition of the classroom, the interactive set-up of the courses and the approachability of the lecturers, among them also legal practitioners.
